Mayor Marx made a correction to the amount financing from \$45,158.50 to \$49,800.00 to include the cost of equipment for the 2021 Chevrolet Silverado.

Commissioner Dubec made a motion to accept item 4.1 as stated by the mayor and giving the mayor authorization with a second by Mayor Marx. Motion carried 2-0.

4.2. Discussion and possible action regarding sewer rates.




4.3. Discussion and possible action regarding property taxes and the City of Thrall 2021-2022 budget.
