

**CITY OF THRALL**  
**ORDINANCE NO. 2021-8-1**

AN ORDINANCE ESTABLISHING RATES AND CHARGES TO BE CHARGED BY THE CITY OF THRALL FOR ITS SERVICES AND SPECIFICALLY THE RATES AND CHARGES FOR WASTEWATER SERVICES; PROVIDING FOR A PENALTY ON WATER BILLS IF NOT PAID BY A CERTAIN DATE; PROVIDING FOR A TERMINATION OF WATER SERVICE AND A RECONNECT FEE IF A BILL IS NOT PAID BY A CERTAIN DELINQUENCY DATE; PROVIDING FOR A SEVERABILITY CLAUSE; PROVIDING FOR A REPEALER CLAUSE; AND PROVIDING FOR A PUBLICATION CLAUSE.

**BE IT ORDAINED BY THE CITY OF THRALL, TEXAS:**

**SECTION 1.** That the wastewater rates to be charged in each calendar month for all users of wastewater services from the City Water Supply, commencing with billings in October 2021, shall be as follows:

Residential & Commercial Minimum billing	1 <sup>st</sup> 2000 gallons	\$19.00
Residential & Commercial Per Gallon	2000 gallons or more	\$3.50 per 1000 gallons
School(s) Flat Rate	No per gallon	\$300.00

**SECTION 2.** That the effective date of the rates and charges set out and established in Section 1, above, shall be effective starting the month of October 2021, and for each calendar month thereafter.

**SECTION 3.** That a penalty of ten percent (10%) of the amount due shall attach to all bills for water services hereunder if not paid by the 15<sup>th</sup> day of the month following the month for which billing was made.

**SECTION 4.** That a water service bill is not paid by the 25<sup>th</sup> day of the month following the month for which billing was made, then the user of such service shall be delinquent and water service to any such delinquent user shall be terminated and a \$50.00 reconnect fee shall apply.

**SECTION 5.** All ordinances or parts of ordinances to the extent only that the same are in conflict herewith are hereby repealed.

**SECTION 6.** Inasmuch as there is and imperative need to adjust the rates for goods and services provided by the City of Thrall as established herein and hereby for the purpose of providing more adequate revenues for the operation, maintenance and improvements of the departments of said City furnishing such goods and services and since such services directly affect the health and sanitation of the citizens of the City of Thrall, this Ordinance shall be effective immediately and

any rules inhibiting the passage of an ordinance on the date on which it is introduced, be, and the same are hereby, declared to be and an emergency measure and that it shall be placed upon it's first, second, and third reading and final passage and it shall become effective immediately, and it is so Passed.

**SECTION 7. Severability.**

If any article, paragraph, or part of a paragraph of this Ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction, the same shall not invalidate or impair the validity, force or effect of any other article, paragraph or part of a paragraph of this Ordinance which shall remain in full force and effect.


**SECTION 8. Repealer.**


**SECTION 9. Publication.**
