**RESOLUTION OF THE CITY OF THRALL, TEXAS  
ISSUING ORDER OF CANCELLATION FOR THE MAY 4, 2024 GENERAL ELECTION  
AND DECLARING ELECTION OF UNOPPOSED CANDIDATES**

**WHEREAS**, the City Council of the City of THRALL has called a general election for MAY 4, 2024, ("General Election") for the purpose of electing a Commissioner; and

**WHEREAS**, the deadline to submit an application for place on the ballot for the General Election was February 16, 2024 at 5:00 p.m. and the deadline to file an application for write-in candidacy for the General Election was February 20, 2024 at 5:00 p.m.; and

**WHEREAS**, the City Secretary is the authority responsible for having the official ballots prepared for the General Election and on February 20, 2024, submitted to the City Council a "Certification of Unopposed Status of Candidates" for the MAY 4, 2024 City of THRALL General Election, attached as **Exhibit A**; and

**WHEREAS**, according to Section 2.053 of the Texas Election Code, if the City Council receives a Certification of Unopposed Status, it may declare each unopposed candidate elected to office;

**NOW THEREFORE, BE IT RESOLVED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF THRALL, TEXAS, THAT:**

1. The "**Certification of Unopposed Status of Candidates**" for the MAY 4, 2024 City of THRALL General Election submitted on February 20, 2024 and attached as **Exhibit A**, is hereby accepted.
2. The **Order of Cancellation**, attached as **Exhibit B** is hereby issued, cancelling the MAY 4, 2024 City of THRALL General Election.
3. Clay Karch is hereby elected to the office of Commissioner and shall be issued a certificate of election in the same manner and at the same time as provided for a candidate elected at the election and shall take his respective office upon his qualification as provided by the laws of the State of Texas.
